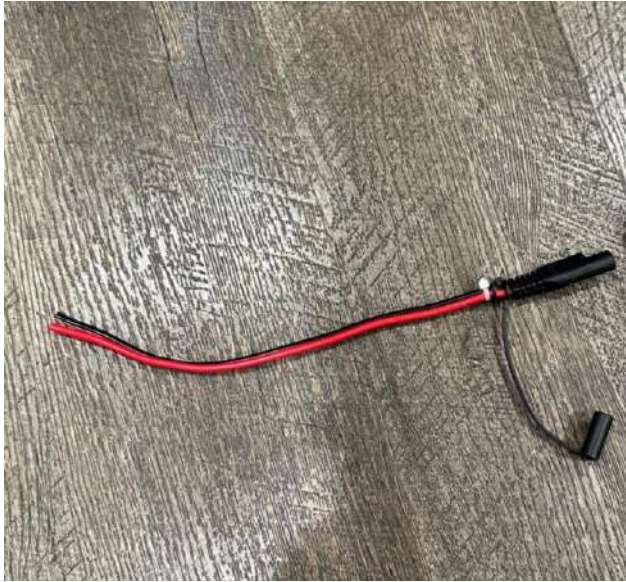

Installation

1. Remove Fixture from box
2. Connect fixture lead to 12V DC/AC power source, using approved splice method



3. Connect fixture lead to light fixture, and push connection into light fixture



- 4. Install light fixture on mounting base (supplied by others) or direct bury. Examples of mounting base include, but not limited to: 2" rigid conduit, 2' floor Flange, (Hali-Brite part # 1067-0002) Hali-Brite Base Can and Cover (Hali-Brite part #L867OLCAN&BP)**



5. Apply 12V DC OR AC power to circuit and visually inspect light fixture.



Maintainence:

1. Replacing Lamps:

- A. Remove lens by removing tamper resistant screw (using #8x 1/2" hex head with button)





- b. Replace lamp with 12VDC/AC LED lamp, 5w max.**
- c. Replace Lens and re-secure #8 Tamper resistant screw.**
